Narrative

Chester Police Department

On March 26, 2016 at approximately 1800 hrs, I was dispatched to 12449 Bentbrook Dr Chesterland, for a citizen's assist. Upon arrival I spoke with Dennis Dudich. He stated that he heard loud engine noises coming from what he believed to be his wooded property behind the house. Upon investigation he discovered his neighbor's son, whom he could only identify as the "youngest Yagour boy," attempting to get a small pickup truck out of the mud. Dennis stated that the "Yagour boy" (believed to be Chris Yagour) was not on Dennis' property but Dennis wanted to document the incident incase Chris happened to eventually cross over onto his property and cause damage to his property. Dennis ventured back out to the area where Chris was stuck, and while still standing on his own property, Dennis took a picture of the truck in the mud.

Dennis stated that Chris became very upset with him and made comments of "bashing his teeth in" and "kicking his ass." I asked if he attempted to cause Dennis harm and he stated no. Dennis went on to state that he believed that Chris was more upset about the vehicle being stuck then he was with Dennis' presence.

Dennis only wanted me to document the incident, and completed a written statement which was attached to this report. Dennis requested that I not make contact with the Yagour family as he felt it could potentially cause more issues. I advised Dennis to contact us if there were any other issues.
