
did engage in sexual conduct with another, not the spouse of the offender, when the offender is a teacher, administrator, coach, or other person in authority employed by or serving in a school for which the director of education and workforce prescribes minimum standards pursuant to division (D) of section 3301.07 of the Revised Code, the other person is enrolled in or attends that school, and the offender is not enrolled in and does not attend that school, contrary to and in violation of R.C. 2907.03(A)(7), Sexual Battery, a felony of the third degree.

SPECIFICATION TO THE FIRST COUNT: The Grand Jurors further find and specify that LOUIS A. CIRINO, is a sexually violent predator as specified in section 2941.148(A)(2) of the Revised Code.

SECOND COUNT: The Grand Jurors further find and present that LOUIS A. CIRINO on or between December 21, 2004 to December 20, 2005, did have sexual contact with another, not the spouse of the offender; cause another, not the spouse of the offender, to have sexual contact with the offender; or cause two or more other persons to have sexual contact when the other person, or one of the other persons, is less than thirteen years of age, whether or not the offender knows the age of that person, contrary to and in violation of R.C. 2907.05(A)(4), Gross Sexual Imposition, a felony of the third degree.

SPECIFICATION TO THE SECOND COUNT: The Grand Jurors further find and specify that LOUIS A. CIRINO, is a sexually violent predator as specified in section 2941.148(A)(2) of the Revised Code.
